It is with great pleasure that I welcome 2023 and the newest IAM-USA Executive Committee members (more information on the new committee members is elsewhere in this issue). In 2022 we began establishing the new normal with hybrid branch meetings and continued development of asset management knowledge and community. Some key accomplishments include:

- 15 branches and 4 in the development stage
- 129 new IAM members
- 190 individuals earned the IAM Certificate or Diploma
- 32 branch meetings were held


### **New USA Chapter Executive Committee Members**
